- Help transfer safety experience and knowledge to the next generation of new workers; and
- Support the growth of the League of Champions.

## TERMS & CONDITIONS

- 1. Character and reputation of the League of Champions:** The League of Champions (LOC) reserves the right to determine the eligibility of any organization, and the right to restrict or prohibit any organization which is found to violate the LOC terms & conditions or membership charter, uses the LOC logo or brand in an inappropriate or unapproved manner, or that in any way detracts from the reputation of the program.
- 2. Payment Terms:** The LOC does not process membership fees unless the application has been approved by the Steering Committee. The Champion Member fee is \$750. Credit cards are not accepted. Cheques must be made payable to "League of Champions." Membership fees are subject to 13% HST.
- 3. Approved Members:** Membership applications will be reviewed by one or more members of the Steering Committee. Approved first-year members are entitled to receive: One (1) customized LOC jersey, and one (1) framed membership charter. An EPS format logo will be requested upon membership approval. The LOC is not responsible for colour matching your company logo. The colours will be matched as closely as possible.
- 4. Membership Terms & Renewal:** The LOC membership term is one year. The invoicing follows a fiscal year from July 1st of the current year to June 31st of the following year.
- 5. Cancellations:** Membership fees are non-refundable. Members who have been cancelled for more than six (6) months must reapply for membership and submit a new application form for consideration.
- 6. Amendments to Terms & Conditions:** The LOC, at its discretion, may make reasonable changes, amendments, or additions to these Terms & Conditions. Any changes shall be binding on the Member.
